MOTION FOR MODIFICATION TO BRIEFING SCHEDULE

The Consumer Financial Protection Bureau requests that the Court modify the briefing schedule for Defendants' Second Amended Motion to Dismiss (Dkt. No. 61) and Defendants' Motion to Stay Further Proceedings (Dkt. No. 64). The current schedule requires that the Bureau file its oppositions by December 11, 2017, and that Defendants file their replies by January 15, 2018. That schedule was set by this Court upon joint motion by all parties (Dkt. No. 87).

Due to recent leadership changes at the Bureau, the Bureau seeks additional time to consult with new leadership before filing its briefs. The Bureau proposes the following revised deadlines:

• January 18, 2018 – deadline for Bureau's opposition to Defendants' motion to dismiss and its opposition to Defendants' motion to stay,

- January 26, 2018 deadline for all amicus briefs in support of the Bureau's opposition to Defendants' motion to dismiss (assuming the Court has granted leave to file such briefs prior to that date), and
- February 22, 2018 deadline for Defendants' reply in support of their motion to dismiss and their reply in support of their motion to stay.

The Bureau contacted Defendants' counsel on November 30, 2017, and asked if they

would consent to this extension. Defendants' counsel indicated on December 4, 2017, that they oppose the motion.

The parties have made two joint requests for an extension of time regarding the briefing on Defendants' motions, one filed by the Bureau and one by the Defendants. This is the third request for an extension of time.

The Bureau certifies that this request is not being made for purposes of improper delay.
